Foreword

Although Prague is a diverse and multicultural city, where roughly one-fourth of the population has a migration background - approximately 350.000 of the city's 1.4 million residents are citizens of other countries - a significant portion of these residents face disenfranchisement due to limited voting rights, which marginalizes their voices in political decision-making. Civil society remains one of the few possibilities for individuals and groups to shape public opinion and participate in solving public and community issues that affect all Prague residents. However, residents with migration backgrounds encounter numerous barriers that hinder their effective participation.

MigAct emerged in June 2022 as a dynamic civic initiative to support the engagement of this large, but underrepresented, population. After a year of preparations, extensive participatory meetings, and dedicated community outreach, MigAct transitioned into an independent Civil Society Organization (CSO)

in autumn 2023. Over the past two years, we've evolved from a mere concept into a vibrant civic association, hosting around 30 events of varying scales. We've built strong partnerships with Prague City Hall and other stakeholders. Our efforts have involved many diverse Prague residents, and we're delighted to see MigAct fulfilling its vital role in the local community.

We will continue to fulfill our mission and achieve our vision in the years to come, and we are excited to work collaboratively with our community to refine our strategic plan and expand our organization's outreach. We plan to work more on the advocacy aspect of our activities and look for innovative ways to support the civic and political participation of diverse Prague residents.
